## 《天津医科大学学报》对参考文献格式的有关要求

本刊执行 GB/T 7714-2015《信息与文献 参考文献著录规则》。以近 5 年公开发表过的文献为主,按参考文献在正文中被引用的顺序,对其编码,按序号列于正文之后。文中引用处以方括号于右上角(阿拉伯数字)注明。研究型论文的参考文献一般不少于 15 条。综述 30~40 条。中外作者的姓名一律“姓前名后”。西方作者的名字部分缩写,不加缩写点。作者不超过 3 人的姓名都写,超过 3 人的,余者写“等”或“et al”。外文刊名缩写按 Index Medicus 格式。在文题之后加文献标识。

### 格式要求:

[1] 期刊:作者(1~3 名均列出,4 名或以上者加“等”或“et al”)。文题[J]。刊名,出版年,卷号(期号):起页码-止页码。

[2] 书籍:著者.书名[M]。版次.出版地:出版者,出版年:起页码-止页码。

[3] 原作者.译著名[M]。译者,译.出版地:出版者,出版年。

[4] 责任者.文集名[C]。出版地:出版者,出版年。

[5] 作者.文题[C]//编者.文集名.出版地:出版者,出版年:起页码-止页码。

[6] 申请者.专利名: 国名,专利号[P]。发布日期。
